

NON-RESIDENT TUITION WAIVER APPLICATION

Please submit this form only after you have been admitted to FIU and your out-of-state residency for tuition purposes has been determined.

Eligibility Criteria

Pursuant to Florida Statute 1009.26 (12)(a) and Board of Governors Rule 7.008(3)(m), FIU is authorized to waive the out-of-state fee for students who meet the following criteria:

- · Demonstrate United States citizenship or lawful presence in the United States; and
- Attended a high school in the state of Florida for 3 consecutive years immediately before graduating from a high school in this state;
 and
- Applied for enrollment to a State University, Florida College System institution, or Florida career center or charter technical career center in Florida within 24 months after high school graduation; **and**
- Submit an official Florida high school transcript as evidence of attendance and graduation.

To demonstrate United States citizenship, U.S. citizens must provide a valid U.S. Passport, Birth Certificate, or Certificate of Naturalization.

To demonstrate lawful presence, Non-U.S. citizens must provide:

Current, valid, and unexpired immigration documents (for example: permanent resident card, or other immigration category documents such as immigration letter, visa document, employment authorization card) each semester.

The provided documentation for Non-U.S. citizens must be valid and unexpired through the end of term for which the waiver is applied.

Note: Decisions for this waiver are made pursuant to Florida state statute 1009.26(12)(a) and Florida Board of Governors Rule 7.008(3)(m). This waiver is only available for up to 110% of the required credits hours of an undergraduate degree or certificate program for which the student is enrolled and will not be applied retroactively. This waiver cannot be applied to non-degree work or graduate degrees and can only be applied to courses which are assessed regular tuition. Flat fee, market rate, self-supporting and other similar courses or programs set-up with different tuition and fee structures are not covered by the waiver. Home school education students are not eligible to receive this waiver. Receipt of this out-of-state fee waiver does **NOT** constitute classification as a Florida resident for tuition purposes.
