

NON-RESIDENT TUITION AND FEES WAIVER APPLICATION FOR ACTIVE DUTY, VETERANS, SPOUSES, AND DEPENDENTS

In accordance with Florida Statute 1009.26(13) and (14), out-of-state tuition and fees shall be waived for covered eligible individuals (Chapters 30, 31, 33, 35, 1606, 1607, and ToE, or Active Duty) who meet any ONE of the following. Check the appropriate box below and submit this signed form along with the appropriate supporting documents to the address at the bottom of this form. By signing this form, I acknowledge approval of this Out-of- State Tuition and Fee Waiver does not constitute a change in my designated residency status. Continuing students receiving the waiver who are only enrolled in online courses must recertify their physical presence in Florida each semester, except for Active Duty Members of the Armed Forces stationed outside of Florida.
